**Vegetative Environment Enhancement
Neighborhood Community Photo Contest Rules**

(*Neighborhood Community; Cluster entry to be of three or more individual resident's properties in the same Neighborhood Community entered as a cooperative entry, or to be of a common public property worked on by three or more people from different residents in the same Neighborhood Community entered as a cooperative entry.)

- 1) Only one entry, (including photos from at least three (3) participants) for one Category, per Entry Form, with 4" X 6" photo(s*) attached, and \$3.00 (or \$1.00 per participant) per entry fee enclosed. All Entry Fees to benefit the B-SB Urban Forestry Project. (landscapes 3-5 photos from each participant, all other categories single photo from each participant)
- 2) Participant clusters may enter one entry in each of the various Categories.

- 5) All entries must be postmarked no later than **August 30, 2017**
- 6) The Contest is open to all clusters if three or more legal residents of Butte-Silver Bow City/County.
- 7) The winner will be determined from all qualified entries
- 8) Awards will be checks made out to the designated cluster coordinator.
- 9) Neighborhood Community Cluster district award winner checks will be mailed to the designated cluster coordinator.
- 10) Greater Community Grand recognition award winners will be notified by telephone, and certificates will be mailed.
- 11) **Photographs will not be returned**, digital copies of winning photos may be requested for publication in media. All accepted photos may be used in various media formats for an unlimited amount of time and at no cost to Alma Higgins Commemorative Competition and Celebration (THE CONTEST and/or AHCCC) or photo contest sponsors. Photo credit is not guaranteed for all uses of image.
- 12) By submitting an Entry Form with photos attached, all entrants acknowledge his, her, their agreement to all The Contest rules and restrictions, and give permission to use entrant's *name* for promotional purposes by the Facilitators/Sponsors/Supporters.
- 13) Contest entrants further agree to the decisions made by the judges. Judges' decisions are final.
- 14) By submitting an Entry Form with photos attached, any winner consents to the use of his or her name, picture, entry photo, and/or likeness thereof for the purposes of promoting Neighborhood Community Vegetative Environment Enhancement, and grants the Alma Higgins Commemorative Competition and Celebration, and The Contest sponsors the right to use the photo entry for publishing, illustration, advertising, trade and promotion, in any medium for said purpose, holding AHCCC harmless from any and all liability that might arise out of or result from the foregoing use.
- 15) Entry signifies that participants will abide by all rules, including providing a true signature on any entry form.
