2-501.11	No vomiting or diarrhea kit on site. Kit can be purchased at Montana Broom and Brush and must be kept on site.	
3-302.11	Raw fish is above ready-to-eat food. Raw beef is above fish. Proper separation will prevent food from cross contamination and will prevent food-borne illness. Person in charge changed the order of the food in fridge and agreed to monitor food so it is in correct order with fish on top, beef next, and chicken on the bottom.	
4-501.115	Chlorine levels were above 200ppm. Demonstrated proper amount of chemical and discussed obtaining test strips. Person in charge agreed to test chemical every time it is made and to use one cap of bleach per one gallon of water.
