note	Facility sometimes cools left over soup. Discussed proper cooling procedures, cooling from 135F to 70F in 2 hours and 70F to 41F in an additional 4 hours. For best cooling results we discussed using a two inch pan and checking temperatures while in the cooling process. We also discussed using a thermometer to monitor hot holding and heating of the soups, being sure to heat soup to 165F and hot hold at 135F.
