1 AN ORDINANCE AMENDING ORDINANCE NO. 09-14 AND TITLE 2, CHAPTER  
2 2.88 OF THE BUTTE-SILVER BOW MUNICIPAL CODE (B-SB MC) ENTITLED  
3 "ANIMAL SERVICES BOARD" AND SPECIFICALLY AMENDING SECTION 2.88.040  
4 ENTITLED "FUNCTIONS POWERS AND DUTIES" AND PROVIDING FOR AN  
5 EFFECTIVE DATE HEREIN

6 SECTION 1: Amendment: Ordinance No. 09-14 and Section  
7 2.88.040 of the B-SB MC shall be and are hereby  
8 amended to read as follows:

9 "2.88.040 Functions, powers and duties. In  
10 addition to the other provisions of this chapter,  
11 the board shall:

12 A. Advise the Council and Chief Executive  
13 on all actions necessary to carry out the  
14 provisions of the animal control  
15 regulations dealing with animal control;

16 B. Ensure that the animal shelter is  
17 operated in a clean and safe manner and  
18 provides humane treatment to animals  
19 confined at the shelter, and is open to  
20 the public at convenient times;

21 C. Perform such other duties as are  
22 described in the various animal control  
23 regulations which are set out in Title 6  
24 of the Butte-Silver Bow Municipal Code;
