

COUNCIL RESOLUTION NO. 14-7

1 A RESOLUTION AMENDING THE BUDGET DURING THE FISCAL YEAR AFTER
2 CONDUCTING A PUBLIC HEARING AT A REGULARLY SCHEDULED MEETING OF
3 THE COUNCIL OF COMMISSIONERS IN ACCORDANCE WITH SECTION 7-6-4006,
4 MCA; APPROPRIATING BUTTE-SILVER BOW GENERAL FUND REVENUE FROM CASH
5 RESERVES TO THE BUTTE-SILVER BOW PARKING COMMISSION BUDGET TO BE
6 EXPENDED IN THE GENERAL FUND AND PROVIDING FOR AN EFFECTIVE DATE
7 HEREIN.

8 WHEREAS, the Butte-Silver Bow Parking Commission Budget has
9 incurred unanticipated expenditures to purchase new
10 software and equipment over and above those anticipated
11 and budgeted for Fiscal Year 2013-2014; and

12 WHEREAS, in order to pay for these unanticipated expenditures,
13 monies from cash reserves need to be appropriated to
14 the Butte-Silver Bow Parking Commission in the amount
15 of \$40,000.00; and

16 WHEREAS, Section 7-6-4006, MCA, allows the Council of
17 Commissioners as the governing body (Council) to amend
18 the budget during the fiscal year to fund unanticipated
19 expenditures after conducting a public hearing; and

20 WHEREAS, a public hearing on the request of the Butte-Silver Bow
21 Parking Commission to appropriate monies to the Butte-
22 Silver Bow Parking Commission Budget to cover
23 unanticipated expenditures to purchase new software and

1 equipment in the amount of \$40,000.00 from cash
2 reserves was held by the Council on March 19, 2014; and
3 WHEREAS, it appearing to the Council, after hearing all
4 testimony at the public hearing held on March 19, 2014
5 that it is in the best interests of the citizens of the
6 City and County of Butte-Silver Bow to appropriate
7 \$40,000.00 from cash reserves to the Butte-Silver Bow
8 Parking Commission Budget for the purpose of purchasing
9 new software and equipment.

10 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF
11 THE CITY AND COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

12 SECTION 1: That \$ 40,000.00 in monies from cash reserves is
13 hereby appropriated to the Butte-Silver Bow
14 Parking Commission Budget for expenditure in the
15 General Fund as follows:
