

COUNCIL RESOLUTION NO. 14-17

1 A RESOLUTION AMENDING THE BUDGET DURING THE FISCAL YEAR AFTER  
2 CONDUCTING A PUBLIC HEARING AT A REGULARLY SCHEDULED MEETING OF  
3 THE COUNCIL OF COMMISSIONERS IN ACCORDANCE WITH SECTION 7-6-4006,  
4 MCA; APPROPRIATING BUTTE-SILVER BOW REVENUE FROM THE CAPITAL  
5 IMPROVEMENT FUND TO THE BUTTE-SILVER BOW LAW ENFORCEMENT  
6 DEPARTMENT BUDGET TO BE EXPENDED IN THE CAPITAL IMPROVEMENT  
7 (BUTTE-SILVER BOW LAW ENFORCEMENT DEPARTMENT BUDGET CAPITAL  
8 IMPROVEMENT MACHINERY AND EQUIPMENT FUND) AND PROVIDING FOR AN  
9 EFFECTIVE DATE HEREIN.

10 WHEREAS, the Butte-Silver Bow Law Enforcement Department has  
11 incurred unanticipated expenditures to purchase a new  
12 police vehicle over and above those anticipated and  
13 budgeted for Fiscal Year 2013-2014; and

14 WHEREAS, in order to pay for these unanticipated expenditures,  
15 monies from the capital improvement fund need to be  
16 appropriated to the Butte-Silver Bow Law Enforcement  
17 Department Budget (Capital Improvement Machinery and  
18 Equipment) in the amount of \$11,300.00; and

19 WHEREAS, Section 7-6-4006, MCA, allows the Council of  
20 Commissioners as the governing body (Council) to amend  
21 the budget during the fiscal year to fund unanticipated  
22 expenditures after conducting a public hearing; and

23 WHEREAS, a public hearing on the request of the Butte-Silver Bow

1 Law Enforcement Department to appropriate monies to the  
2 Butte-Silver Bow Law Enforcement Department Budget  
3 (Capital Improvement Machinery and Equipment) to cover  
4 unanticipated expenditures to purchase a new police  
5 vehicle in the amount of \$11,300.00 from the capital  
6 improvement fund was held by the Council on May 14,  
7 2014; and

8 WHEREAS, it appearing to the Council, after hearing all  
9 testimony at the public hearing held on May 14, 2014  
10 that it is in the best interests of the citizens of the  
11 City and County of Butte-Silver Bow to appropriate  
12 \$11,300.00 from the capital improvement fund to the  
13 Butte-Silver Bow Law Enforcement Department (Capital  
14 Improvement Machinery and Equipment) Budget for the  
15 purpose of purchasing a new police vehicle.

16 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF  
17 THE CITY AND COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

18 SECTION 1: That \$ 11,300.00 in monies from the capital  
19 improvement fund is hereby appropriated to the  
20 Butte-Silver Bow Law Enforcement Department Budget  
21 for expenditure in the Butte-Silver Bow Law  
22 Enforcement Department Capital Improvement  
23 Machinery and Equipment Fund as follows:
