ORDINANCE NO. 14-7

1 AN ORDINANCE AMENDING BUTTE-SILVER BOW ORDINANCES NO. 479, 564,  
2 601, 02-7, 03-6, AND 13-7 AND TITLE 3, OF THE BUTTE-SILVER BOW  
3 MUNICIPAL CODE (B-SB MC) ENTITLED "REVENUE AND FINANCE", AMENDING  
4 CHAPTER 3.12 ENTITLED "CONTRACT PURCHASES"; AMENDING SECTIONS  
5 3.12.002 AND 3.12.015 AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

6 SECTION 1: Amendment: Ordinance No. 479 and Section 3.12.002  
7 of the Butte-Silver Bow Municipal Code (B-SB MC)  
8 shall be and are hereby amended to read as  
9 follows:

10 "3.12.002 Scope. The scope of this chapter is to  
11 adopt by reference provisions of Part 23 of  
12 Chapter 5 of Title 7 of the Montana Code Annotated  
13 (MCA) entitled "County Contracts" and to adopt by  
14 reference parts of Part 3 of Chapter 4 of Title 18  
15 and Part 4 of Chapter 4 of Title 18 of the Montana  
16 Code Annotated (MCA) entitled "Montana Procurement  
17 Act" and to adopt Part 5 of Chapter 2 of Title 18  
18 of the Montana Code Annotated (MCA) entitled  
19 "Alternative Project Delivery Contracts" and the  
20 accompanying rules and specifically Sections 18-  
21 24-242, 18-4-303, 18-4-304, 18-4-306, 18-4-307,  
22 18-4-308, 18-4-309, 18-4-312, 18-4-401, 18-4-402,  
23 18-4-403, 18-4-404, 18-4-405, 18-4-406, and 18-4-  
24 407, 18-2-501, 18-2-502, and 18-2-503 MCA, and the

1 rules accompanying these sections, as the county  
2 purchases law for use by the local government of  
3 the city and county of Butte-Silver Bow, Montana.”

5 SECTION 2: Amendment: Ordinance No. 479 and Section 3.12.015  
6 of the Butte-Silver Bow Municipal Code (B-SB MC)  
7 shall be and are hereby amended to read as  
8 follows:

9 "3.12.015 Procurement Act. In accordance with the  
10 provisions of Sections 18-4-124, MCA, the council  
11 adopts the following parts of the Montana  
12 Procurement Act and the accompanying rules (as set  
13 forth in Section 18-4-121, et.seq., MCA) and the  
14 provisions of Title 18, chapter 2, Part 5:

15 "A - I" - Same

16 "J Part 5 of Chapter 2 of Title 18 MCA  
17 entitled "Alternative Project Delivery Contracts."

18 SECTION 3: Effective Date. This Ordinance shall be in full  
19 force and effect from and after thirty (30) days  
20 after its passage and approval.
