

COUNCIL RESOLUTION NO. 14-18

1 A RESOLUTION CONTINUING THE LOCAL VEHICLE TAX FOR FISCAL YEAR
2 2014-2015 ON VEHICLES SUBJECT TO A REGISTRATION FEE UNDER
3 SECTIONS 61-3-321(2) OR 61-3-562, MCA AT A RATE OF 0.5% OF THE
4 VALUE DETERMINED UNDER SECTION 61-3-503, MCA IN ADDITION TO THE
5 REGISTRATION FEE IMPOSED UNDER SECTIONS 61-3-321(2) OR 61-3-562
6 MCA, AS AUTHORIZED BY SECTION 61-3-537, MCA; DECLARING THAT A
7 PUBLIC HEARING HAS BEEN HELD ON THE LOCAL VEHICLE TAX AND
8 PROVIDING FOR AN EFFECTIVE DATE HEREIN.

9 WHEREAS, THE Montana Legislature has provided a remedial
10 addition revenue source to counties for certain
11 district court costs and other general government
12 operations by enacting Section 61-3-537, MCA which
13 allows counties to impose a local vehicle tax on
14 vehicles subject to a registration fee under Sections
15 61-3-321(2) or 61-3-562, MCA at a rate of 0.5% of the
16 value determined under Section 61-3-503, MCA in
17 addition to the registration fee imposed under
18 Sections 61-3-321(2) or 61-3-562, MCA; and

19 WHEREAS, the Council of Commissioners of the City and County
20 of Butte-Silver Bow, State of Montana, having held a hearing on
21 July 2, 2014, find that an additional funding source is

1 necessary and further finds that an additional funding source
2 is available and necessary to fund general government
3 operations.

4 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS
5 OF THE CITY AND COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

6 SECTION 1: That a local vehicle tax is hereby continued for
7 fiscal year 2014-2015 on vehicles subject to a
8 registration fee under Section 61-3-321(2) or
9 61-3-562, MCA at a rate of 0.5% of the value
10 determined under Section 61-3-503, MCA in
11 addition to the registration fee imposed under
12 Section 61-3-321(2) through 61-3-562, MCA.

13 SECTION 2: That the local vehicle tax is payable at the
14 same time and in the same manner as the
15 registration fee imposed under Sections 61-3-
16 321(2) or 61-3-562, MCA. The local vehicle tax
17 shall be distributed 50% to the City and County
18 of Butte-Silver Bow, State of Montana and the
19 remaining 50% to both the City and County of
20 Butte-Silver Bow State of Montana and the Town
21 of Walkerville, State of Montana, with such
22 apportionment to each on the basis of

1 population. The actual distribution shall be
2 accomplished pursuant to Section 61-3-537, MCA.

3 SECTION 3: That the revenues generated from the local
4 vehicle tax collected pursuant to this
5 Resolution which are distributed to the City and
6 County of Butte-Silver Bow, State of Montana
7 shall be used for certain county district court
8 costs and for general government operations if
9 funds are available.

10 SECTION 4: That this Resolution shall be in full force and
11 effect from and after passage and approval.
