

COUNCIL RESOLUTION NO. 14-30

1 A RESOLUTION LEVYING A SPECIAL ASSESSMENT FOR THE FISCAL YEAR  
2 2014- 2015 AGAINST THE PROPERTY FROM WHICH SOLID WASTE IS TO BE  
3 COLLECTED AND REMOVED FROM EACH INDIVIDUAL DWELLING COLLECTION  
4 UNIT FOR THE PURPOSE OF DEFRAYING THE COST AND EXPENSES OF  
5 COLLECTING AND REMOVING SAID SOLID WASTE; LEVYING A LANDFILL  
6 FACILITY ACCESS FEE FOR THE FISCAL YEAR 2014 - 2015 AGAINST THE  
7 PROPERTY FROM WHICH SOLID WASTE IS TO BE DISPOSED OF FOR EACH  
8 INDIVIDUAL DISPOSAL UNIT FOR THE PURPOSE OF DEFRAYING THE COST  
9 AND EXPENSES OF MAINTAINING AND OPERATING SAID SOLID WASTE  
10 DISPOSAL FACILITY AND ESTABLISHING A SCHEDULE OF FEES FOR SUCH  
11 ASSESSMENT AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

12 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY AND  
13 COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

14 SECTION 1: COLLECTION AND REMOVAL OF SOLID WASTE FROM  
15 DWELLINGS: That for the purpose of paying the  
16 annual cost and expenses of collecting solid  
17 waste, including trash, debris and filth from  
18 dwelling buildings within the City and County of  
19 Butte-Silver Bow in accordance with the  
20 provisions of Chapter 8.08 of the Butte-Silver  
21 Bow Municipal Code (B-SB MC), the assessment

1 hereby named and described is hereby levied upon  
2 said property for the fiscal year 2014 - 2015 as  
3 a special assessment as provided by law for the  
4 said purpose, and said assessment is hereby set  
5 in the amount a special assessment is provided by  
6 law for the said purpose; and said assessment is  
7 hereby set in the amount of seventy-three dollars  
8 and no/100's (\$73.00) for each individual  
9 dwelling collection unit. This assessment  
10 entitles each individual dwelling collection unit  
11 to have up to four (4) approved containers for  
12 collection and removal of solid waste.

13 SECTION 2: DISPOSAL OF SOLID WASTE AT SANITARY SOLID WASTE  
14 DISPOSAL LANDFILL FACILITY: That for the purpose  
15 of paying the cost and expenses of maintenance  
16 and operation of the Butte-Silver Bow Sanitary  
17 Solid Waste Disposal Landfill Facility (Landfill  
18 Facility) in order to dispose of solid waste,  
19 including trash, debris and filth from dwelling,  
20 commercial and industrial buildings and uses  
21 within the City and County of Butte-Silver Bow in

1 accordance with the provisions of Chapter 8.08 of  
2 the B-SB MC, the Landfill Facility Access Fee  
3 hereby named and described is hereby levied upon  
4 said property for fiscal year 2014 - 2015 as a  
5 special assessment as provided by law for the  
6 said purpose, and said assessment is hereby set  
7 out as follows:

8 a) in the amount of twenty-five dollars  
9 and 37/100's (\$25.37) for each individual  
10 dwelling disposal unit; and

11 b) in the amount of twenty-five dollars  
12 and 37/100's (\$25.37) for each unit assigned for  
13 each commercial and industrial building or use.

14 SECTION 3: That the list of real property assessed and  
15 levied upon and the names of the owners thereof,  
16 as far as known, with the amount levied against  
17 said property is herein after set forth.

18 SECTION 4: That said special assessment and Landfill  
19 Facility Access Fee shall be placed upon the  
20 assessment rolls and collected in the same manner  
21 as taxes for the fiscal year 2014 - 2015.

1 SECTION 5: That this Resolution shall be in full force and  
2 effect from and after passage and approval.
