2 ORDINANCE NO. 14-9

3 AN ORDINANCE AMENDING SECTION 2 OF BUTTE-SILVER BOW ORDINANCE NO. 134  
4 AND SECTION 2.04.010 OF THE BUTTE-SILVER BOW MUNICIPAL CODE (B-SB MC);  
5 ADJUSTING THE ANNUAL SALARIES OF THE CHIEF EXECUTIVE, COUNTY  
6 ATTORNEY, SHERIFF, CLERK AND RECORDER, TREASURER, ASSESSOR, CITY  
7 JUDGE, JUSTICE OF THE PEACE, AUDITOR, SUPERINTENDENT OF SCHOOLS,  
8 CLERK OF THE DISTRICT COURT, CORONER AND MEMBERS OF THE COUNCIL OF  
9 COMMISSIONERS AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

10 SECTION 1: Amendment: Section 2 of Ordinance No. 134 and Section  
11 2.04.010 of the Butte-Silver Bow Municipal Code (B-SB  
12 MC) shall be and are hereby amended to read as  
13 follows:

14 "2.04.010 Salaries Designated. The Butte-Silver Bow  
15 officials named in this section shall receive an  
16 annual salary according to the following schedule  
17 effective July 1, 2014.

18 (a) The Chief Executive shall receive \$105,614.08  
19 annually.

20 (b) The County Attorney shall receive \$110,004.38  
21 annually, in accordance with the applicable sections  
22 of State law for full time County Attorney in counties  
23 with populations greater than 30,000 residents. In  
24 addition to the annual salary, the County Attorney

1 shall receive the annual discretionary longevity  
2 salary adjustment for county attorneys, as set forth  
3 in State law.

4 (c) The Sheriff shall receive \$81,496.81 annually.

5 (d) The Clerk and Recorder shall receive \$73,438.90  
6 annually.

7 (e) The Treasurer shall receive \$71,246.64  
8 annually.

9 (f) The Assessor shall receive \$71,246.64 annually.

10 (g) The City Judge shall receive \$71,246.64  
11 annually.

12 (h) Each Justice of the Peace shall receive  
13 \$71,246.64 annually.

14 (i) The Auditor shall receive \$71,246.64 annually.

15 (j) The Superintendent of Schools shall receive  
16 \$71,246.64 annually.

17 (k) The Clerk of the District Court shall receive  
18 \$71,246.64 annually.

19 (l) The Coroner shall receive \$35,623.33 annually.

20 In addition to the annual salary, the Coroner shall  
21 receive \$360.00 annually as reimbursement for travel  
22 expenses.

23 (m) Each member of the Council of Commissioners  
24 shall receive \$6,499.88 annually. In addition to the

annual salary, each member of the Council of Commissioners shall receive \$1,200.00 annually as reimbursement for travel expenses.

(n) The Chairman of the Council of Commissioners shall receive additional \$2,954.00 annually.

(o) The Public Administrator shall receive such compensation as is provided for that office by State law."

SECTION 2: Effective Date. This Ordinance shall be in full force and effect from and after thirty (30) days after passage and approval.
