ORDINANCE NO. 14-12

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 204 AND SECTION 10.40.050 OF THE BUTTE-SILVER BOW MUNICIPAL CODE (B-SB MC) ENTITLED "SPEED LIMIT;" ESTABLISHING A 35 MPH SPEED LIMIT BEGINNING AT THE INTERSECTION OF U.S. INTERSTATE 15 AND BUXTON ROAD AND THEN PROCEEDING WESTWARD TO THE WYE INTERSECTION OF BUXTON ROAD WITH NORTH AND SOUTH BUXTON ROAD AND PROVIDING FOR AN EFFECTIVE DATE HEREIN.

SECTION 1: Amendment: Ordinance No. 204 and Section 10.40.050 of the Butte-Silver Bow Municipal Code (B-SB MC) shall be and are hereby amended to read as follows:

"10.40.050 Established - Streets designated. In accordance with Section 61-8-303, MCA and when signs are erected giving notice thereof, it is unlawful for any person to drive a motor vehicle at a speed greater than the speed as set forth in the following schedule on the street or highway or parts of streets or highways as follows:

force and effect from and after thirty (30) days
