

COUNCIL RESOLUTION NO. 15-31

1 A RESOLUTION LEVYING SPECIAL ASSESSMENTS TO PAY THE COSTS OF
2 LIGHTING WITHIN THE SPECIAL IMPROVEMENT DISTRICTS ENUMERATED BY
3 THIS RESOLUTION WITHIN THE CITY AND COUNTY OF BUTTE-SILVER BOW,
4 STATE OF MONTANA, FOR FISCAL YEAR 2015 - 2016 AND PROVIDING FOR
5 AN EFFECTIVE DATE HEREIN.

6 BE IT RESOLVED BY THE COUNCIL OF COMMISSIONERS OF THE CITY AND
7 COUNTY OF BUTTE-SILVER BOW, STATE OF MONTANA:

8 SECTION 1: That pursuant to the operation of Special
9 Lighting Districts authorized by the laws of
10 Montana and pursuant to resolutions passed by the
11 Former City Council of the former City of Butte
12 and by the Council of Commissioners of the City
13 and County of Butte-Silver Bow, Montana created
14 the various Special Improvement Districts as
15 enumerated in Section 2 below, a special
16 assessment is hereby levied for the purpose of
17 defraying the costs of providing said lighting
18 services for the fiscal year 2015 - 2016 against
19 the several lots and parcels of lots within said
20 districts, enumerated in Section 2 of this
21 Resolution, as the same are recorded and

1 described in the office of the Clerk and Recorder
2 of the City and County of Butte-Silver Bow, State
3 of Montana.

4 SECTION 2: That the Council of Commissioners does hereby
5 estimate as near as practicable the cost of
6 maintaining the following Special Improvement
7 Districts as now established within the City and
8 County of Butte-Silver Bow, State of Montana, for
9 the fiscal year 2015 - 2016, as follows:

2 Board of County Commissioners of Silver Bow
3 County, Montana under the former county form of
4 government allowing the provision of lighting
5 services to residents, a special assessment is
6 hereby levied for the purpose of defraying the
7 costs of providing said lighting services for the
8 fiscal year 2015 - 2016 against the several lots
9 and parcels of lots within said districts,
10 enumerated in Section 4 of this Resolution, as
11 the same is recorded and described in the office
12 of the Clerk and Recorder of the City and County
13 of Butte-Silver Bow, State of Montana.

15 SECTION 4: That the Council of Commissioners does hereby
16 estimate as near as practicable the cost of
17 maintaining the Special Improvement Districts as
18 enumerated within the City and County of Butte-
19 Silver Bow, State of Montana, for the fiscal year
20 2015 - 2016, as follows:

19 upon the assessment rolls and collected in the
20 same manner as taxes.
